Chapters 1 and 2 of the Laws of 2009 signed into law by Governor Paterson in February 2009 increased the Insurance Department's appropriation by \$180 million and authorized the Department to assess insurers for the total value of the enacted appropriation for fiscal year 2008-09. The Department is making an additional assessment to comply with this legislation.

The enacted appropriation for the fiscal year ending March 31, 2009 is \$ 443.0 million. Based on the appropriation and an estimate of your New York business for 2008, your company's additional assessment has been computed in the amount of \$14,815,579.00.
